Travel insurance advice

Swimming activity advice

For excursions involving swimming activities the parent/carer must complete the 'Swimming activity advice form' in English advising of their child's swimming ability and return it to the school. The form provides information on the kinds of swimming activities that will occur, where they will be held and consent to participate in these activities. The school will provide the flotation devices below to students who require assistance in the water.

Water activity advice

For excursions involving water activities the parent/carer must complete the 'Water activity advice form' in English advising of their child's swimming ability and return it to the school. This is a precautionary measure. Although no swimming activities are intended the student could accidentally fall in the water. The form provides information on the kinds of water activities that will occur, where they will be held and consent to participate in these activities.

Privacy advice

The information requested on this form is being collected by the NSW Department of Education. The information is being obtained for the purpose of ascertaining relevant medical information, requirements and other health care related needs about your child who is currently enrolled at the school and who may participate in school excursions, sporting activities or other educational or school activities conducted by or in conjunction with this school.

It will be used by the school to plan, to support students, and to minimise risks when conducting the school excursions or other related school activities.

Other persons or agencies that may be provided with this information include, but are not limited to, volunteers and members of external organisations who join with the school or are otherwise involved in the planning or delivery of the excursion, sporting or other school activity; and persons that may be called upon to provide health care treatment or other assistance during or as a consequence of such excursions or activities.

Provision of this information is voluntary, however, if you do not provide all or any of the information requested, your child cannot participate in the excursion. In such circumstances, the school will make available a sound alternative educational experience.

Provision of this information will significantly assist the school in planning a safer educational activity. It will be stored securely. If you have any concerns about provision of this information, please contact the school principal to discuss further.
